Dear Applicant,

The attached Solicitor application must be completed prior to receiving authorization to solicit door to door within the Village of Carbon Hill.

The issuance of a Solicitor Permit is conditional upon compliance with all Village ordinances and the result of a background investigation into your character and background. All information on the application must be answered completely and legibly. Any false statement or omission of information will be cause for solicitor permit suspension, revocation or grounds for the Village to refuse to issue the permit. Your signature on the application certifies that the information you have provided is true and accurate.

Application for a permit must be submitted in person. Your current Driver's License or State Identification Card must be presented. A \$25 non-refundable application fee is due at the time of submittal. A copy of any pamphlets or advertising material you distribute when soliciting must also be submitted with your application.

All approved permits are valid for one day. There will be a \$25.00 per day renewal fee due at the time of request.

Any solicitor ticketed by the Grundy County Sheriff's Department for soliciting without a permit will pay any fines due to the Village of Carbon Hill prior to a Permit or renewal being issued.

Upon approval, a Peddler and Solicitor's Permit will be issued. The permit must be carried at all times while soliciting in the Village of Carbon Hill and exhibited whenever requested to do so by any police officer or any person solicited.

Licensed solicitors shall be allowed to conduct solicitation activities between the hours of 10:00 a.m. and 8:00 p.m.

A copy of the Village Ordinance as it pertains to Peddler and Solicitor regulations is attached for your information.

The Village Clerk's Office will contact you 10 days after receiving completed application and nonrefundable application fee regarding your Solicitor Application.
